- Have a letter of support from an eligible organisation that you are engaging with for the Immersion Experience confirming the organisation's commitment to the applicant and the experience
- Have a professional development and/or career plan that demonstrates how the Immersion Experience will benefit your career pathway
- Has no outstanding Women Leaders in Sport program acquittal and/or grant reporting requirements to the ASC
- Is not currently employed by the ASC
- The supporting organisation is not named in the National Redress Scheme for Institutional Child Sexual Abuse on its list of [Institutions that have not joined or signified their intent to join the Scheme](#).
- The Immersion experience must be completed by **30 November 2025**.

The ASC may at its sole discretion, offer an applicant special consideration if an eligibility requirement set out in these guidelines cannot be met due to extenuating circumstances.
